ⁱ "Parent" means a person having legal parental responsibility for the child or who is the legal guardian of the child.

[&]quot; "Member" of Emmanuel Church or another Christian Church means regular attendance by the child together with at least one Parent at that church, and regular attendance shall mean attendance for a minimum of six services in each of the eight successive quarters in the twenty four month period immediately preceding the date of the application as evidenced in the church attendance register signed at the end of every service.

[&]quot; "Sibling" means a brother or sister, an adopted brother or sister, a step-brother or sister, or a child of the Parent's partner, where, in each case, the child for whom the school place is sought has her or his Home within the same Family unit at the same address as the sibling.

[&]quot; "Main School" means reception to year 6

[&]quot; "Christian Church" means a church belonging to Churches Together in Britain and Ireland or a member church of the Evangelical Alliance.

^{vi} "Home" means the child's principal place of residence with his or her Family unit. Where the child for whom the school place is sought ordinarily lives with each Parent separately each week, then the child's principal place of residence is where the child lives for the majority of each week.
